

**BRUCE CHUNG’S WESTCHESTER MARTIAL ARTS ACADEMY  
(BRUCE CHUNG’S TAE KWON DO)  
CORONAVIRUS/COVID-19 LIABILITY WAIVER AND RELEASE OF CLAIMS**

In consideration of being allowed to participate in any Bruce Chung’s Westchester Martial Arts Academy, Inc. (“BCWMAA, Inc.”) related “Program,” defined as including but not limited to classes at 250 Halstead Avenue, classes at any other location, and/or taking class online, I agree to the following:

1. I acknowledge the contagious nature of the Coronavirus/COVID-19 and the guidelines set by the CDC and other public health authorities.
2. I further acknowledge that BCWMAA, Inc. has put in place preventative measures to reduce the spread of the Coronavirus/COVID-19.
3. I agree to keep my child(ren) home, and to contact the studio, if anyone in my family is experiencing any symptoms of the illness such as cough, fever, sore throat, shortness of breath or chills.
4. I further acknowledge that BCWMAA, Inc. cannot guarantee that I will not become infected with the Coronavirus/COVID-19. I understand that the risk of becoming exposed to and/or infected by the Coronavirus/COVID-19 may result from the actions, omissions, or negligence of myself.
5. I voluntarily seek services provided by BCWMAA, Inc., its employees and staff, and acknowledge that I am increasing my risk to exposure to the Coronavirus/COVID-19, and acknowledge that I must comply with all set procedures set by BCWMAA, Inc. in accordance with the CDC, to reduce the spread.
6. I understand that signing this release discharges BCWMAA Inc., any employee or staff, from any liability or claim against the studio with respect to any bodily injury, illness, death, medical treatment that arise from, or have connection to, any services received from BCWMAA, Inc.
7. I understand that this liability waiver and release extends to BCWMAA, Inc. together with all owners, employees and staff members.
8. While participating in events held or sponsored by BCWMAA, Inc. “social distancing” must be practiced and face coverings worn at all times to reduce the risks of exposure to Coronavirus/COVID-19. Because Coronavirus/COVID-19 is extremely contagious and is spread mainly from person-to-person contact, BCWMAA, Inc. has put in place preventative measures to reduce the spread of Coronavirus/COVID-19. However, BCWMAA, Inc. cannot guarantee that its participants, volunteers, partners, or others will not become infected with Coronavirus/COVID-19.
9. In light of the ongoing spread of Coronavirus/COVID-19, individuals who fall within any of the categories below should not engage in BCWMAA, Inc. events. By attending a BCWMAA event, you certify that you do not fall into any of the following categories:
  - a. Individuals who currently or within the past fourteen (14) days have experienced any symptoms associated with Coronavirus/COVID-19, which include fever, cough, and shortness of breath among others;
  - b. Individuals who have traveled at any point in the past fourteen (14) days either internationally or to a community in the U.S. that has experienced or is experiencing sustained community spread of Coronavirus/COVID-19; or
  - c. Individuals who believe that they may have been exposed to a confirmed or suspected case of Coronavirus/COVID-19 or have been diagnosed with Coronavirus/COVID-19 and are not yet cleared as non-contagious by state or local public health authorities or the health care team responsible for their treatment.

**DUTY TO SELF-MONITOR:**

Participants agree to self-monitor for signs and symptoms of Coronavirus/COVID-19 (symptoms typically include fever, cough, and shortness of breath) and, contact BCWMAA, Inc. if he/she experiences symptoms of Coronavirus/COVID-19 within 14 days after participating with BCWMAA, Inc..

**ASSUMPTION OF THE RISK.** I acknowledge and understand the following:

1. Program participation includes possible exposure to and illness from infectious diseases including but not limited to Coronavirus/COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist;
2. I knowingly and freely assume all such risks related to illness and infectious diseases, such as Coronavirus/COVID-19, even if arising from the negligence or fault of the Released Parties; and
3. I hereby knowingly assume the risk of injury, harm and loss associated with the Activity, including any injury, harm and loss caused by the negligence, fault or conduct of any kind on the part of the Released Parties.

**RELEASE AND WAIVER.** I HEREBY RELEASE, WAIVE AND FOREVER DISCHARGE ANY AND ALL LIABILITY, CLAIMS, AND DEMANDS OF WHATEVER KIND OR NATURE AGAINST BCWMAA, Inc. AND ITS AFFILIATED PARTNERS AND SPONSORS, INCLUDING IN EACH CASE, WITHOUT LIMITATION, THEIR DIRECTORS, OFFICERS, EMPLOYEES, VOLUNTEERS, AND AGENTS (THE “RELEASED PARTIES”), EITHER IN LAW OR IN EQUITY, TO THE FULLEST EXTENT PERMISSIBLE BY LAW, INCLUDING BUT NOT LIMITED TO DAMAGES OR LOSSES CAUSED BY THE NEGLIGENCE, FAULT OR CONDUCT OF ANY KIND ON THE PART OF THE RELEASED PARTIES, INCLUDING BUT NOT LIMITED TO DEATH, BODILY INJURY, ILLNESS, ECONOMIC LOSS OR OUT OF POCKET EXPENSES, OR LOSS OR DAMAGE TO PROPERTY, WHICH I, MY HEIRS, ASSIGNEES, NEXT OF KIN AND/OR LEGALLY APPOINTED OR DESIGNATED REPRESENTATIVES, MAY HAVE OR WHICH MAY HEREINAFTER ACCRUE ON MY BEHALF, WHICH ARISE OR MAY HEREAFTER ARISE FROM MY PARTICIPATION WITH ANY AND ALL PROGRAM ACTIVITY AT BCWMAA, Inc. OR ANY OTHER LOCATION OR TO THE ALLEGED EXPOSURE TO THE COVID-19 VIRUS WHETHER DIRECTLY OR INDIRECTLY.
